Resident Parking. Except during such times as may be reasonably necessary to wash a Resident's vehicle or clean the garage on a Lot or perform other similar short-term activities necessitating removal of vehicles from a garage, vehicles of Residents shall not be parked anywhere in the Development except wholly within the Resident's garage, carport, or driveway.

The Oaks is working hard to reduce the parking issues, but we need your help. If you have a vehicle that is parked in guest parking, please move it to your driveway, garage, or carport.

Vehicles not moved, will be cited and/or towed.

REMINDER

Registration with Association. All vehicles operated within the Development by Residents must be registered with the Association by submitting a written notice with of the year, make, model and license number of the vehicle to the Association Office.
