Pump 1 was completely clogged on a recent check due to things beyond toilet paper and human waste being flushed down the toilets and drains. Please take time to have a conversation with all adults and children in your home, particularly teenagers, to ensure EVERYONE, residents and guests, are aware that we cannot have grease (bacon grease!!), oil, wipes, diapers and feminine hygiene products, etc. put into our wastewater system OR WE ALL RISK HUGE EXPENSE TO REPAIR OR REPLACE parts of our system.







# **RV/Boat Storage**

Please help us to make the RV/Boat Storage Space a safer area by attending to your space at least every few months. In particular, knock down wasp nests, cobwebs, etc. The Oaks is also going to try placing wasp traps in various areas to help keep "sting" risk down, but we all need to work together to ensure that our RV/Boat Storage does not start to look like a junk yard and present physical harm risks!

We are expanding our RV Storage Space area, adding approximately 12 additional spaces, so if you have a need for a space, please contact the office to get put on our waiting list. Spaces should be available in the November 2020 timeframe.
